#### 1 Accounting policies

#### 11 Accounting convention

The financial statements are prepared under the historical cost convention

The financial statements are prepared on the basis of going concern which assumes that the company will be in operational existence for the forseeable future. This depends upon the continued support of the shareholders who have undertaken to provide such support to enable the company to meet ite debts as asnd when they fall due.
