1. General information

The company is a private company limited by shares, registered in England and Wales. The address of the registered office is 220 Park View, Whitley Bay, Tyne & Wear, NE26 3QR.

2. Statement of compliance

These financial statements have been prepared in compliance with Section 1A of FRS 102, 'The Financial Reporting Standard applicable in the UK and the Republic of Ireland'.

3. Accounting policies

Basis of preparation

The financial statements have been prepared on the historical cost basis. The financial statements are prepared in sterling, which is the functional currency of the entity. The company year end was shortened in the prior period to fall in line with the service charge trust accounts.

Service charges

Under section 42 of the Landlord and Tenant Act 1987, service charge funds are held in trust by the management company on behalf of the tenants. Such funds do not belong to the management company and are therefore not accounted for by it.

Income statement

The company is dormant as defined by section 1169 of the Companies Act 2006.
