The directors present their report and the financial statements for the year ended 31 December 2014.

Principal activity

The principal activity of the company is providing loan finance to fellow group companies.

Results and dividends

The profit for the year, after taxation, amounted to £5,518,000 (2013: loss £6,202,000).

On 29 July 2014, the company paid an interim dividend of £82,000,000 (2013: £nil) to GE Capital Corporation (Investment Properties) Limited, its immediate parent undertaking.

On 24 November 2014, the company paid a further interim dividend of £73,000,000 (2013: £nil) to GE Capital Corporation (Investment Properties) Limited, its immediate parent undertaking.

The directors do not recommend the payment of a final dividend (2013: £nil).

Notes to the financial statements

1. Accounting policies

1.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention and in accordance with applicable accounting standards.

On the basis of their assessment of the company's financial position and resources, the directors believe that the company is well placed to manage its business risks. Therefore the company's directors have a reasonable expectation that the company has adequate resources to continue in operational existence for the foreseeable future. Thus they continue to adopt the going concern basis of accounting in preparing the annual financial statements.

1.2 Cash flow

The company, being a subsidiary undertaking where 90% or more of the voting rights are controlled within the group whose consolidated financial statements are publicly available, is exempt from the requirement to draw up a cash flow statement in accordance with FRS 1.

1.3 Taxation

Taxation for the year is based on the profit/(loss) for the year.

Full provision is made for deferred tax liabilities arising from all timing differences between the recognition of gains and losses in the financial statements and recognition in the tax computation.

A net deferred tax asset is recognised only if it can be regarded as more likely than not that there will be suitable taxable profits from which the future reversal of the underlying timing differences can be deducted.

Deferred tax assets and liabilities are calculated at the tax rates expected to be effective at the time the timing differences are expected to reverse.

Deferred tax assets and liabilities are not discounted.

1.4 Transactions with related parties

The company, as a wholly owned subsidiary undertaking of General Electric Company, has taken advantage of an exemption contained in FRS 8, "Related Party Disclosures", in preparing its financial statements. This exemption allows the company not to disclose details of transactions with other group companies or investees of the group qualifying as related parties, as the consolidated financial statements of General Electric Company, in which the company is included, are publicly available.

2. Auditors' remuneration

Remuneration of £2,604 (2013: £2,604) paid to the auditors for their services to the company was borne by a fellow group undertaking.
