AND

IN THE MATTER OF THE INSOLVENCY ACT 1986

UPON HEARING THE PETITION presented to this court on 26 February 2001 (the "Petition")

AND UPON the order dated 27 February 2001 for the appointment of joint provisional liquidators of the Company

AND UPON the application of (1) Stephen Roland Browne and (2) Ian Harvey Dean (in their capacities as the provisional liquidators of the Company) dated 21 February 2024

AND UPON READING THE EVIDENCE

AND UPON the court being satisfied that the Company ought to be wound up on the bases set out in section 122(1)(d) and (g) of the Insolvency Act 1986 ("**IA 1986**")

AND UPON the court being satisfied that it was appropriate to wind up the Company without requiring the Petition to be amended

AND UPON the court being satisfied on the evidence that the EC Regulations on Insolvency Proceedings does apply and that these are main proceedings within the meaning of the Regulation

AND UPON HEARING Counsel, Jennifer Meech, on behalf of the provisional liquidators and the Society of Lloyd's

IT IS ORDERED THAT

1. Margent Capital Management Limited (03407319) be wound up by this court under the provisions of the Insolvency Act 1986
2. The appointment of Stephen Roland Brown and Ian Harvey Dean as the provisional liquidators of the Company pursuant to Rule 4.31 of the 1986 Rules and/or Rule 7.39 of the 2016 Rules be terminated and they be released from office pursuant to section 174(5) of IA 1986 at the time and date of the winding up order
3. Pursuant to section 174(6) of IA 1986, the provisional liquidators are granted discharge from all liability both in respect of acts or omissions of theirs in the provisional liquidations and otherwise in relation to their conduct as the provisional liquidators with effect from the date and time of the winding up order
4. The costs of petitioner, and of the Society of Lloyd's, of the said Petition be paid out of the assets of the Company
