- 3 If at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to section 1032(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 03424691 plc
- 4 An Office Copy of this Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off
- 5 The Registrar of Companies do advertise notice of this Order in his official name in the "London Gazette".
6. Upon the restoration of the Company, the Claimant be appointed as liquidator pursuant to section 108 of the Insolvency Act 1986
7. The Claimant be remunerated in his capacity as liquidator on the basis of time cost properly incurred to be drawn at his discretion
- 8 The costs of this application be an expense of the liquidation
