#### 1 Accounting policies

#### Company information

Plas Gwynfa Limited is a private company limited by shares incorporated in England and Wales. The registered office is Two Parklands Business Park, Great Park, Rubery, Birmingham B45 9PZ.

#### Accounting convention

These financial statements have been prepared in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" ("FRS 102") and the requirements of the Companies Act 2006 as applicable to companies subject to the small companies regime.
