1 Statutory information

The Gables Rest Home Ltd is a private company, limited by shares, registered in England and Wales, registration number 3426263. The registered office is 17 Cefn Y Bryn, Llanrhos, Conwy, LL30 1NH, Wales.

2 Compliance with accounting standards

The accounts have been prepared in accordance with the provisions of FRS 102 Section 1A Small Entities. There were no material departures from that standard.

3 Accounting policies
