#### Present

Terry Sadler, Mona Morris, John Andrews and Pamela Marsden Dorothy Brown arrived late but was part of the latter discussions.

## Matters arising

#### Sale of the Cliff railway

Pamela explained that a sale was in the process of being agreed. A loan agreement had been agreed with ICOF and the Aberystwyth Cliff railway company (for the rest of the sale price). A new lease was been written by the County Council. The County Council has promised £20,000 towards acquisition of the railway.

#### Appointment of manager for the Cliff railway

Pamela introduced John Andrews to the meeting who is a trained engineer. The meeting affirmed his appointment. John then, gave a resumé of his work experience and his short-term and long-term ideas for the railway.

### Appointment of additional directors

Terry Sadler and John Andrews were appointed as directors in addition to Mona, Pamela and Dorothy who formed the original board of directors.

#### Affirmation of the Sale

The board affirmed that Constitution hill Ltd should go ahead and buy the Cliff railway as written to the Aberystwyth Cliff railway company £90,000 deposit and £60,000 in installments over 5 years with interest. Pamela as company Secretary will deal with matters pertaining to sale and keep the board informed.

#### Appointment of Professionals

The board affirmed Richard Morris as the company solicitor. Lionel Curtis was affirmed as the company's architect. Terry suggested Paul Wallis (a civil engineer) to be asked onto the board. The board agreed Terry would approach Paul Wallis.

#### Fund-raising

John to approach Rotary Club, Inner Wheel, Variety Club, Aber Rag and National companies. After sale, the board to write to the Town Council offering for John to come and speak to them with the intent for them to be better informed and possibly, sponsor part of the renovation process.

#### Open Day

The railway will be open from 30 March. There will be an official opening on Saturday 4 April when various people will be invited from the locality e.g. local businesses, Councillors, Council Officers and the like.
