

UPON HEARING COUNSEL FOR the Petitioners

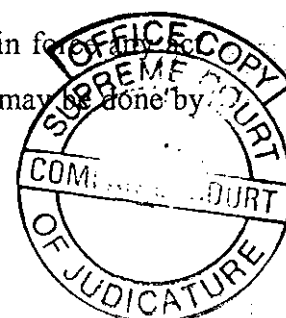
AND UPON READING the evidence

IT IS ORDERED THAT during the period for which this order is in force, the affairs, business and property of Federal-Mogul Global Growth Limited ("the Company") be managed by the administrators hereinafter appointed pursuant to the provisions of section 8 of the Insolvency Act 1986 ("the Act") for the following purposes, namely:

- (1) The survival of the Company and the whole or some part of its undertaking as a going concern;
- (2) The approval of a voluntary arrangement with its creditors under Part 1 of the Insolvency Act 1986;
- (3) The sanctioning of a compromise or arrangement between the Company and such persons as are mentioned in Section 425 of the Companies Act 1985;

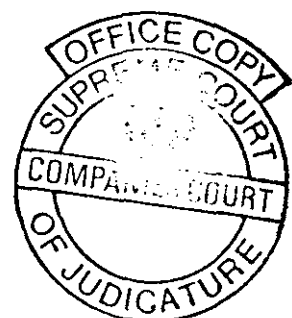
AND IT IS ORDERED THAT Simon Vincent Freakley, James John Gleave and Ian Peter Phillips ("the Administrators") of Kroll Buchler Phillips, be appointed Joint Administrators of the Company

AND IT IS DECLARED THAT during the period for which this Order is in force, any act required or authorised under any enactment to be done by the Administrators may be done by all or any of the persons for the time being holding that office



AND IT IS ORDERED THAT the costs of the Petition including the costs of the preparation of the independent report prepared by the Administrators (including the legal costs thereof) be paid as an expense of the administration

AND IT IS ORDERED THAT service of the Petition upon the Administrators be dispensed with
