Each preference share is entitled to one vote (pari passu with the ordinary shares). On a return of capital on winding-up, the preference shares are entitled, in priority to any payment to the holders of the ordinary shares, to receive an amount equal to the nominal amount paid up on those shares. The preference shares have no right to receive a dividend nor a right to participate in the profits of the company. The shares are redeemable at any time at the option of the company.
