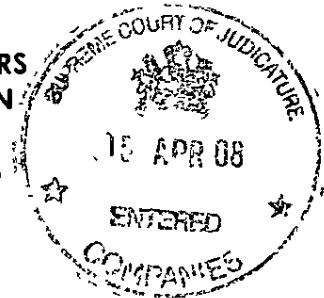

(2) In respect of each Administration listed in Schedule A

- a Andrew John Duncan be removed as joint administrator, and
- b Geoffrey Wayne Bouchier be appointed as joint administrator

(3) In respect of each Liquidation listed in Schedule B

- a Andrew John Duncan be removed as joint liquidator, and
- b Geoffrey Wayne Bouchier be appointed as joint liquidator

(4) In respect of each Bankruptcy listed in Schedule C

- a Andrew John Duncan be removed as joint trustee in bankruptcy, and
- b Geoffrey Wayne Bouchier be appointed as joint trustee in bankruptcy

(5) Andrew John Duncan shall be released from further liability as officeholder of the cases set out in Schedules A to C 28 days after advertisement of the transfer of appointments in the London Gazette

(6) The creditors of the companies and individuals listed in Schedules A to C shall have permission to apply to vary or discharge this order insofar as it relates to the estate of which they are a creditor, or make representations to the Secretary of State as regards Andrew John Duncan's release from further liability, within 28 days of their being given notice of it

(7) The costs of and occasioned by this application shall be divided equally between the cases set out in Schedules A to C and, subject to paragraph 8 below and there be specific liberty to apply to the court for the costs to be assessed in default of agreement

(8) In no case shall the amount charged to any insolvent estate in respect of the costs of this application exceed 10% of the aggregate value of available funds and the value of immediately realisable assets ("available assets") in that estate. In any case where there are no assets in the insolvent estate or where the proportion of costs exceeds 10% of the available assets, the proportion of costs or that part of it which exceeds 10% of the available assets shall be paid pro-rata from the cases set out in Schedules A to C where there are sufficient assets available

(9) Creditors shall be given notice of this order, and of the liberty to apply herein, to the creditors of the companies and individuals set out in Schedule A to C or the members of the companies identified in Schedule B as being in Members Voluntary Liquidation, such notice to be given

- a by advertisement in the London Gazette within 21 days of the date of this order, and
- b at the first convenient opportunity to do so without incurring any additional expense
