The declaration of solvency, sworn by the directors prior to the commencement of the liquidation showed an intercompany debt of £1 due from Enfield Energy Centre Limited ("EEC") The debt has been distributed to EEC (see "Distributions" below)

Creditors

Notices to creditors to prove their claims in the liquidation were advertised in The London Gazette and The Times newspapers on 9 October 2012. No creditors were forthcoming as a result of these advertisements

Tax

The Company's tax advisors advised that the Company was dormant for corporation tax purposes. At the request of the joint liquidators, HM Revenue & Customs ("HMRC") confirmed that the Company had no outstanding corporation tax returns or liabilities, that it will not raise enquiries into any pre or post liquidation periods and that it has no objection to the liquidators calling a final meeting of members to conclude the liquidation

A similar assurance was sought and received from HMRC in respect of VAT and PAYE

Distributions

On 9 July 2014 the joint liquidators declared a first and final distribution of the assets of the Company to EEC, as the sole beneficial shareholder of the Company

The distribution was at the rate of £1 per £1 Ordinary share and was effected by set off against the debt of £1 due to the Company by EEC

Replacement of liquidator

Please note that on 14 August 2013 an order was made in the High Court appointing Allan Watson Graham as Joint Liquidator of the Company in place of Jeremy Simon Spratt, following Mr Spratt's retirement from KPMG LLP In accordance with the Order, creditors and members were given notice of the Order by advertisement in the London Gazette on 21 August 2013
