TRUSTEES' REPORT FOR THE YEAR ENDED 31 DECEMBER 2005

The Trustees present their report and accounts for the year ended 31 December 2005.

Objects of the charity

The charity is a company limited by guarantee. The charity's objects are to promote education, in particular through the provision of educational fellowships for visiting Indian academics. The policies adopted in furtherance of these objects are the provision of funding to universities to support the fellowships. Recipients of donations are decided by the Board of Trustees.

The governing document is the company's Memorandum and Articles of Association.

The charity's constitution requires a minimum of three trustees. Trustees must be members of the company and the power to appoint and remove trustees rests with the members in General Meeting.

Review of activities

The charity has funded fellowships at universities in Cambridge, Edinburgh, Hull, Oxford and Wales during previous years. During the year ended 31 December 2005, the following activities took place:

Dr Rana Pratap Behal, Reader in History, Delhi University, was appointed by Cambridge University as the Singhvi Fellow 2005. His research interest was in the area of Indian labour history with focus on the history of tea plantation labour in Assam during the British rule in India.

Edinburgh University decided to leave the L Singhvi visiting Professorship fund to accumulate. Plans were however made to invite Professor Sumit Sarkar of Delhi University to give a public lecture on 14 March 2006 on the theme of 'The many nationalisms of late-colonial and post-colonial India' followed by a seminar on 16 March 2006 on the theme of 'The problemisation of binaries in South Asian history writing'

There were no visiting Fellows during the year at Hull, Oxford and Wales. Reports of activities are expected in due course.

Statement of trustees' responsibilities

The trustees are required under the law applicable to charities in England and Wales to prepare accounts for each financial year which give a true and fair view of the state of the charity's financial activities during the year and of its financial position at the end of the year. - a) select suitable accounting policies and apply them consistently;
- b) make judgements and estimates that are reasonable and prudent;
- c) state whether applicable accounting standards and statements of recommended practice have been followed, subject to any departures disclosed and explained in the accounts;
- d) prepare the accounts on the going concern basis unless it is inappropriate to presume that the charity will continue in operation.

The trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity and which enable then to ensure that the accounts comply with the Charities Act 1993. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

1 Accounting policies

a) Basis of preparation

The accounts have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective June 2002). In preparing the accounts the charity follows best practice as laid down in the Statement of Recommended Practice (SORP) on Accounting and Reporting by Charities (revised 2005).

b) Accumulated funds

Restricted funds are subject to specific conditions by donors as to how they may be used. There were no restricted funds at the beginning of the year or at the end of the year.

Designated funds comprise funds which have been set aside at the discretion of the Trustees for specific purposes. The purposes and uses of the designated funds are set out in the notes to the accounts.

c) Voluntary income
