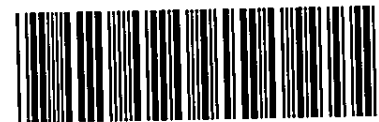

IT IS ORDERED THAT

- 3 Pursuant to Rule 7 10B(3) Gordon Smythe Goldie be appointed as joint replacement office-holder in place of Allan David Kelly in respect of each of the cases listed in Parts 1 and 2 of the Schedule hereto from the date of this Order
- 4 Pursuant to Rule 7 10B(3) Andrea Lynn Marshall be appointed as joint replacement office-holder in place of Matthew James Higgins in respect of each of the cases listed in Part 1 of the Schedule hereto from the date of this Order
- 5 Pursuant to Rule 7 10B(3) Andrea Lynn Marshall be appointed as joint replacement office-holder in place of Allan David Kelly in respect of each of the cases listed in Part 3 of the Schedule hereto save for the case known as 3RI Limited (in liquidation) from the date of this Order
- 6 Creditors and, in the case of solvent liquidations, members, shall be given notice of this Order by advertisement in the London Gazette, placed by the replacement office-holders referred to above within 14 days of the making of this Order and all requisite notifications will be filed at Companies House within 14 days of this making of this Order
7. The provisions of Rules 2 47(3A) and 4 49C-CVL(3)(a) do not apply in this case The period for the provision of progress reports remains the same as the original date in place prior to this block transfer having effect.
- 8 The costs of making this application (not to exceed £200 per case) be apportioned equally amongst the cases listed the Schedule hereto and that
 - 8 1 where the case relates to an administration the pro rata share of the costs of this application shall be payable as an expense of the administration, and
 - 8 2 where the case relates to any insolvency proceedings other than administration, the pro rata share of the costs of this application shall be payable as an expense of the insolvency proceedings
