FOR THE YEAR ENDED 31 DECEMBER 2018

1. Accounting policies

Dormant status

The Company was dormant (within the meaning of Section 480 of the Companies Act 2006) throughout the year ended 31 December 2018. The Company has not traded during the year or during the preceding financial year. During these periods, the Company received no income and incurred no expenditure and therefore made neither profit nor loss.

Basis of preparation

The financial statements have been prepared under the historical cost convention and in accordance with applicable accounting standards.

The Company transitioned from previously extant UK GAAP to FRS102 as at 1 January 2014.

The Company has taken advantage of the provision within FRS102 relating to dormant companies and has elected to retain its accounting policies for reported assets, liabilities and equity at the date of transition until there is any change to those balances or any new transactions are undertaken.
