PARTIES:

- (1) The persons whose names and addresses are set out in Part 1 of Schedule 1 (the "Vendors" and this expression includes the legal personal representatives of any individual Vendor); and
- (2) Interdependence Group Limited (registered no: 3473878) the registered office of which is at AMC House, Chantry Street, Andover, Hants SP10 1DE (the "Purchaser").

BACKGROUND:

- (A) The Vendors have agreed to sell, and the Purchaser has agreed to purchase, the entire issued share capital of Interdependence Limited (the "Company") on the terms set out in this Agreement.
- (B) The Company was incorporated in England with registered number 2654877 and has an authorised share capital of £350,000 divided into
 - (1) 150,000 Founder Shares of £1 each,
 - (2) 100,000 Ordinary `A' Shares of £1 each, and
 - (3) 100,000 Cumulative Redeemable Preference Shares of £1 each

of which 132,750 Founder Shares and 9,666 Ordinary `A' Shares (totalling 142,416 shares) have been issued and are fully paid or credited as fully paid.

MAIN AGREEMENT:

1. <u>DEFINITIONS AND INTERPRETATION</u>

1.1 Definitions

In this Agreement, including the Schedule, except where the context otherwise requires, the words and expressions set out in the first column shall have the meanings set out in the second column:-

agreed terms any document, the terms of which have been

agreed between the parties to this Agreement and which, for the purposes of identification, has

been initialled by them or on their behalf

Completion completion of the sale and purchase of the Shares

in accordance with clause 4

Consideration Shares the respective classes of shares of £1 each in the

Purchaser to be allotted to the Vendors in

accordance with Clause 3;

Shares all the issued shares of £1.00 each in the

Company.

1.2 Headings and Clauses

The headings in this Agreement shall not affect its interpretation. References to clauses and the Schedule are to the clauses of, and the Schedule to, this Agreement.

2. TRANSFER OF SHARES

2.1 Sale and Purchase

- 2.1.1 Subject as set out in this Agreement, each of the Vendors, with full title guarantee, shall sell, or procure the sale of, and the Purchaser shall purchase, the full legal and beneficial interest in the number of Shares shown opposite that Vendor's name in Part 2 of the Schedule.
- 2.1.2 The Purchaser shall not be obliged to complete the purchase of the Shares unless the purchase of all of the Shares is completed simultaneously in accordance with the provisions of this Agreement.

2.2 No Liens etc.

The Purchaser shall acquire good title to the Shares free from all charges, liens, encumbrances, equities and claims of any kind and together with all rights which now are or at any time after the date of this Agreement may become attached to them including any dividend or other distribution declared, paid, made or created after the date of this Agreement.

2.3 <u>Pre-emption Rights</u>

The Vendors hereby waive all rights of pre-emption under the Articles of Association of the Company or otherwise in respect of the sale of the Shares to the Purchaser under this Agreement (or shall procure that all such rights are waived).

3. <u>CONSIDERATION</u>

The consideration for the purchase of the Shares shall be the allotment and issue on Completion to each Vendor of that number and class of Consideration Shares of the Purchaser as is set out opposite that Vendor's name in Part 3 of the Schedule.

4. **COMPLETION**

4.1 Date and Place

The sale and purchase of the Shares shall be completed at the offices of the Purchaser's Solicitors immediately following the signing of this Agreement or at such other place and/or on such other date as may be agreed between the Vendors and the Purchaser.

4.2 <u>Vendors' Obligations</u>

At Completion the Vendors will deliver (or procure the delivery of) to the Purchaser:-

- 4.2.1 duly executed transfers into the name of the Purchaser (or as it may direct) in respect of their respective Shares together with definitive certificates for the same;
- 4.2.2 any other documents which may be required to give good title to the Shares or otherwise to give effect to the terms of this Agreement;
- 4.2.3 the certificate of incorporation, any certificates of incorporation on change of name, the common seals (if any), all minute books, share registers, share certificate books (with any unissued share certificates) and other statutory books and cheque books and other books and records of the Company;
- 4.2.4 all documents of title relating to the assets of the Company; and
- 4.2.5 all the financial and accounting books and records of the Company.

4.3 <u>Directors' Resolutions</u>

On Completion, the Vendors shall procure that a resolution is passed by the directors of the Company approving for registration (subject to their being duly stamped) the transfers mentioned in Clause 4.2.1.

4.4 Satisfaction of Consideration

The Purchaser shall, against compliance with the preceding provisions, on Completion satisfy the Consideration in the manner specified in clause 3.

5. **SURVIVAL OF PROVISIONS**

Notwithstanding Completion, the provisions of this Agreement shall, except insofar as then implemented or performed, remain in full force and effect and shall continue to bind, and to be enforceable by, the Purchaser or its sucessors or assigns or, as the case may be, the Vendors and shall not be extinguished or affected by any other event or matter except a specific and duly authorised written waiver or release from the Purchaser or, as the case may be, the Vendors.

6. ENTIRE AGREEMENT

6.1 Whole Agreement

This Agreement, when taken together with any document in the agreed terms (or the executed engrossments of them) and any other documents to be entered into pursuant to this Agreement, constitutes the entire agreement and understanding between the parties with respect to all matters referred to in this Agreement, to the exclusion of any terms implied by law which may be excluded by contract. This clause shall not apply to any statement or representation made fraudulently.

6.2 Variation

No variation of this Agreement or of any document in the agreed terms or any other documents to be entered into pursuant to this Agreement shall be effective unless it is in writing and signed by or on behalf of each of the parties.

7. **FURTHER ASSURANCE**

At any time (whether before or after Completion) the Vendors shall (at the cost and expense of the Purchaser) do and execute or procure to be done and executed all necessary acts, documents and things reasonably requested of it by the Purchaser to give effect to this Agreement and the transactions contemplated in or by it.

8. **INVALIDITY**

If any provision in this Agreement is held to be illegal, invalid or unenforceable, in whole or in part, under any enactment or rule of law, such provision or part shall, to that extent, be deemed not to form part of this Agreement but the legality and enforceability of the remainder of this Agreement shall not be affected.

9. **GOVERNING LAW**

This Agreement and (save as expressly stated in) any document to be entered into pursuant to this Agreement shall be governed by and construed in accordance with English law and the parties irrevocably submit to the exclusive jurisdiction of the English courts to settle any disputes which may arise out of or in connection with this Agreement or any such document.
