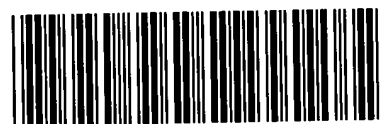

The company was dormant during the year under review.


