Objects, Organisation and Activities

The Company manages the licensing arrangements and the provision of services to the non-UK licensees of Common Purpose

Review of Progress

Licence fee income has been increased from some countries and the development of new programmes indicates that licence fees will increase further in the coming year

Finances

The attached financial statements show the current state of the finances, which the directors consider to be satisfactory

Results for the Period

The profit before taxation amounted to £ 23,659 (2005 £19,802) All profits are covenanted to the parent charity

Directors' responsibilities

Company law requires the directors to prepare financial statements for each financial year, which give a true and fair view of the state of affairs of the company and of the profit or loss of the company for that period In preparing those financial statements, the directors are required to,

- select suitable accounting policies and then apply them consistently,
- make judgements and estimates that are reasonable and prudent,
- state whether applicable accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements,
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the company will continue in business

The directors are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the company and to enable them to ensure that the financial statements comply with the Companies Act 1985 They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention of fraud and other irregularities

In determining how amounts are presented within items in the profit and loss account and balance sheet, the directors have had regard to the substance of the reported transaction or arrangement, in accordance with generally accepted accounting policies or practice

INDEPENDENT AUDITORS' REPORT TO THE SHAREHOLDERS OF

CIVILIA LTD

We have audited the financial statements of Civilia Limited for the year ended 31 July 2006, which comprise the Profit and Loss Account, the Balance Sheet and the related notes. These financial statements have been prepared under the historical cost convention and the accounting policies set out therein.

Basis of audit opinion


