1 GENERAL INFORMATION

Stanton Redcroft Limited is a company limited by shares. It was incorporated in England and its registered office is 52c Borough High Street, London SE1 1XN. The principal activity of the company is that of a dormant company and as such does not carry out a trade of its own.

2 ACCOUNTING POLICIES

Statement of Compliance

Basis of preparation
