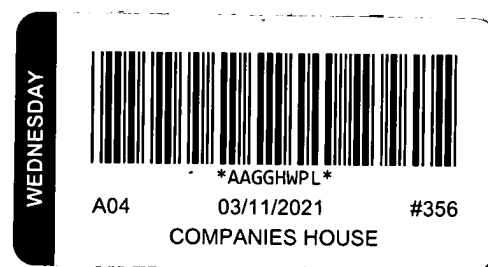


The company did not trade during the current or preceding period and has made neither profit nor loss, nor any other recognised gain or loss.
