The Statement of Financial Position remained at total net assets of £36,000 (31 December 2016: £36,000) since the Company has not traded in the financial year.

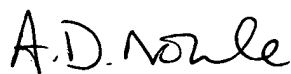
KEY PERFORMANCE INDICATORS ("KPIs")

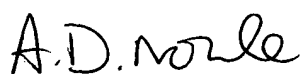
DIRECTORS' INDEMNITY

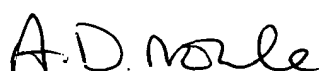
For the year ended 31 December 2017 the company was entitled to exemption from audit under section 480 of the Companies Act 2006 relating to dormant companies.
