**WRITTEN RESOLUTIONS**

Pursuant to Chapter 2 of Part 13 of the Companies Act 2006 (the “**Act**”), the directors of the Company proposes that the following resolutions be passed as special resolutions of the Company (the “**Resolutions**”):


**SPECIAL RESOLUTIONS**

- 1 “**THAT**, pursuant to section 641(1)(a) of the Act, the entire amount standing to the credit of the share premium account of the Company as at the date of these Resolutions, being an amount in the aggregate sum of GBP 491,109,014 be and is hereby cancelled and extinguished;
- 2 “**THAT**, pursuant to section 641(1)(a) of the Act, reduce the Company’s issued share capital by GBP 19,085,303.295489, from GBP £19,085,780.44, comprising 1,908,578,044 Ordinary A shares of GBP 0.01 each, to GBP 477.144511, comprising 1,908,578,044 Ordinary A shares of GBP 0.00000025 each, by reducing the nominal value of each of the Company’s issued Ordinary A shares by GBP 0.00999975, from GBP 0.01 to GBP 0.00000025; and
- 3 “**THAT**, the amount arising upon the reduction of capital pursuant to resolution numbers 1 and 2 above (i.e., GBP 510,194,317.295489) be credited to the profit and loss reserves of the Company.”

## AGREEMENT

3. If you do not agree to the Resolutions, you do not need to do anything; you will not be deemed to agree if you fail to reply.
4. Once you have indicated your agreement to the Resolutions, you may not revoke your agreement.
5. Pursuant to section 642 of the Act, the Resolutions must be passed not more than 15 days after the date of the solvency statement relating to the reduction of capital, therefore unless sufficient agreement has been received for the Resolutions to be passed within 15 days after the date of the solvency statement, they will lapse. If you agree to the Resolutions, please ensure that your agreement reaches us before the end of this period.
