#### IT IS ORDERED THAT:

- 1. Where required, the proceedings herein to be transferred to the High Court for the purpose of making the order sought and thereafter to be transferred back to the respective County Court.
- 2. Charles Christopher Stewart Macmillan (Outgoing Officeholder) be removed from office in respect of each of the cases listed in Parts 1 and 2 of the Schedule attached to this order from the date of this order.
- 3. Frances Bernadette Henshaw (the Applicant) of Beever and Struthers, St George's House, 215-219 Chester Road, Manchester, M15 4JE, be appointed as replacement officeholder in respect of each of the cases listed in Part 1 of the Schedule attached to this order from the date of this order (the Block Transfer Cases).
- 4. The Applicant remain in office as the sole appointee of the case listed in Part 2 of the Schedule (the Continuing Case).
- 5. The Outgoing Officeholder shall receive his release as liquidator or trustee in bankruptcy (as applicable) 28 days after the giving of notice to creditors or members (as applicable)
