Directors' report

The directors present their annual report and the audited financial statements for the year ended 31 December 2012

Principal activities

The principal activity of the company is the provision of staffing services to the healthcare sector

Business review

During the year the company incurred an operating loss of £9,000 (2011 loss of £93,000)

The results for the year are set out in the profit and loss account on page 6

The directors expect the level of activities to remain similar to that of 2012

Risk management

The company actively considers and manages its risks. These include risks associated with

- Generating revenue from its clients. In order to maintain the company's client base and geographical coverage, management perform regular business reviews to monitor performance against expectations.
- Credit risk The group's principal financial assets are bank balances and cash and trade and other receivables. The
 group's credit risk is primarily attributable to its trade receivables. This is managed by regular monitoring of
 client trade receivable accounts. An allowance for impairment is made where there is an identified loss event
 which, based on previous experience, is evidence of a reduction in the recoverability of the cash flows.

The credit risk on liquid funds is limited because the counterparties are banks with high credit-ratings assigned by international credit-rating agencies

The group has no significant concentration of credit risk, with exposure spread over a large number of counterparties and customers

Liquidity risk In order to maintain liquidity to ensure that sufficient funds are available for ongoing operations
and future developments, the company regularly review the cash flows of the business and where deficits are
forecast, the company is able to draw on group funding

Notes to the accounts Year ended 31 December 2012

1. Accounting policies

The following accounting policies have been applied consistently throughout the year and the preceding year in dealing with items which are considered material in relation to the financial statements

Basis of preparation

The accounts have been prepared in accordance with applicable United Kingdom accounting standards, and under the historical cost convention. Under FRS 1 the company is exempt from the requirement to prepare a cash flow statement on the grounds that a parent undertaking includes the company in its published consolidated financial statements.

Going concern

Notwithsanding net liabilities of £101,000 (2011 £92,000), the directors have prepared the financial statements on a going concern basis which they consider appropriate for the following reasons. The company is a subsidiary company and is therefore reliant on the group to operate within the facilities in place with the group's banks. The directors have reviewed the cash flow forecasts for the group and company for a period of twelve months from the date these financial statements are signed. Taking account of inherent market uncertainties and of reasonably possible changes in trading performance, the directors are satisfied that the group will generate sufficient cash flows to allow the group to operate within the covenants on its senior loan facility and allows the group and company to meet their liabilities as they fall due for payment for the foreseeable future.

Accordingly the directors continue to adopt the going concern basis in preparing the financial statements on the basis of a written commitment of financial support from its ultimate parent company Independent Clinical Services Group Limited The directors have considered the ability of Independent Clinical Services Group Limited to provide this support and are satisfied with their ability to do so

Further disclosure is provided in the consolidated financial statements of Independent Clinical Services Group Limited

Turnover

Turnover represents amounts receivable for goods and services net of VAT and including any inter-group trading and relates wholly to the United Kingdom Turnover from the placement of temporary staff represents the gross sales value of hours worked and is recognised on a weekly basis

Related parties

Advantage has been taken of the exemption within FRS 8 (Related Party Transactions) not to disclose transactions between wholly owned group companies

Cash flow statement

The company has taken advantage of the exemption under FRS1 (Revised) not to publish a cash flow statement, as the consolidated financial statements of its parent undertaking Independent Clinical Services Group Limited are publicly available

1. Accounting policies (continued)

Tangible fixed assets and depreciation

Tangible fixed assets are stated at cost or fair value when acquired less depreciation and when appropriate, provisions for impairment. Depreciation is provided on all tangible fixed assets at rates calculated to write off the cost less estimated residual value, of each asset on a straight line basis over its expected useful life as follows

Computer equipment Three to five years

The carrying values of tangible assets are reviewed for impairment if events or changes in circumstances indicate the carrying value may not be recoverable

Taxation

The charge for taxation is based on the result for the year and tax rates and laws that have been enacted or substantively enacted at the balance sheet date. It takes into account taxation deferred because of timing differences between the treatment of certain items for taxation and accounting purposes. The company is part of a UK group for group related purposes. No payment is made for tax losses surrendered under the group relief provisions.

Deferred tax is recognised, without discounting, in respect of all timing differences between the treatment of certain items for taxation and accounting purposes which have arisen but not reversed by the balance sheet date. A deferred tax asset is regarded as recoverable and therefore recognised only to the extent that, on the basis of all available evidence, it can be regarded as more likely than not that there will be suitable taxable profits from which the future reversal of the underlying timing differences can be deducted
