## WRITTEN SPECIAL RESOLUTIONS

- THAT the Memorandum of Association of the Company be altered with respect to its objects by 1. the adoption of a new clause 3(y) in the following form and the renumbering of the existing clause 3(y) as 3(z):
  - "Subject to and in accordance with due compliance with the provisions of Sections 155 3(y)to 158 (inclusive) of the Companies Act 1985 (the "Act") (if and so far as such provision shall be applicable) to give, whether directly or indirectly, any kind of financial assistance (as defined in Section 152(a) of the Act) for such purpose as is specified in Section 151(1) and/or Section 151(2) of the Act"
- 2. THAT the giving of financial assistance by the Company (pursuant to sections 155 to 158 (inclusive) of the Companies Act 1985) by the entry into by the Company of, and the performance by it of its obligations under, an agreement for the sale and purchase and deed of option (the "Put and Call Option") relating to sale and purchase of shares in the share capital of CSTIM CFAS Limited dated on or about the date hereof (but prior to the completion of the sale and purchase of the entire issued share capital of the Company) to be made between the Company, Arnold Eber and Morse plc be and is hereby approved.
- 2. THAT approval for the Company to enter into, execute, deliver and perform the Company's obligations under the Put and Call Option and any other documents and acts necessary in connection with the said financial assistance be given hereby notwithstanding that, in doing so, the Company might be held to be giving financial assistance for the purposes of sections 151 and 152 of the Companies Act 1985.
