"Sublease" means the aircraft lease agreement relating to the aircraft between Chemco Equipment Finance Ltd and the Borrower dated 14.6.84 as first novated on 10.12.85 to Security Pacific Financing Services Ltd and then supplemented and amended and novated to Virglease Limited on 31st July 1991 and amended by the Supplemental Agreement.
