

SUPPLEMENTAL SECURITY AGREEMENT

#### **PARTIES**

- 1 THE COMPANIES whose names, registered numbers and registered offices are set out in Schedule 1 (Onginal Chargors) (the "Companies")
- 2 THE ROYAL BANK OF SCOTLAND PLC acting through its office at 280 Bishopsgate, London EC2M 4RB as agent and trustee for the Secured Parties (as defined in the Facility Agreement) (the "Security Agent")

#### **BACKGROUND**

- A This deed is supplemental to a Security Agreement dated 11 December 2014 made between (1) the Companies and (2) the Security Agent (the "Security Agreement")
- B Each Company is obliged by the Security Agreement and the Facility Agreement dated 11 December 2014 made between amongst others (1) the Companies and (2) the Security Agent (the "Facility Agreement") to mortgage the New Property to the Security Agent
- C The parties intend this document to take effect as a deed notwithstanding the fact that the Security Agent may only execute this document under hand

#### **OPERATIVE PROVISIONS**

#### 1 Definitions and interpretation

#### 11 Definitions

Unless the context requires otherwise, terms defined in or for the purposes of the Security Agreement shall have the same meaning when used in this deed (including the parties and background sections) and in addition the following terms shall have the following meanings in this deed (including the parties and background sections)

Finance Documents: the meaning given to it in the Facility Agreement,

New Charged Assets the New Property and the assets referred to in clauses 2.2 and 2.3,

New Property. the property or properties briefly described in Schedule 2 (New Property) to this deed

#### 12 Interpretation

- 1 2 1 The provisions of clause 1 2 (Construction) and clause 1 4 (Secured Liabilities) of the Security Agreement shall also apply to this deed as if set out (with any necessary modifications) in this deed
- The provisions of clause 1.3 (Nature of security over real property) of the Security Agreement shall also apply to references in this deed to the New Property

#### 2 Grant of security

As a continuing security for the payment or discharge of the Secured Liabilities, Witherslack Group Limited with full title guarantee hereby

- 2 1 grants to the Security Agent a charge by way of legal mortgage over all of the New Property,
- 2.2 charges to the Security Agent by way of first fixed charge all Property Interests relating to the New Property, and

2.3 assigns to the Security Agent all Insurance Policies relating to the New Property

#### 3 Land Registry

In respect of any of the New Property or part of or interest in any of the New Property title to which is registered at the Land Registry each Company (to the extent that such Company can do so) hereby consents to the entry of the following restriction on the register of its title to such New Property

"No disposition of the registered estate by the proprietor of the registered estate is to be registered without a written consent signed by the proprietor for the time being of the charge dated [] in favour of The Royal Bank of Scotland PLC referred to in the charges register or, if appropriate, signed on such proprietor's behalf by its conveyancer".

#### 4 Representations and warranties

On the date of this deed, each Company makes the representations and warranties set out in clauses 21 16(a) and (b), and clauses 21 21 - 21 22 (*Representations*) of the Facility Agreement in so far as the representations and warranties relate to the New Property

#### 5 Incorporated provisions

- 5 1 Subject to clause 5 2, all the provisions of the Security Agreement are deemed to be incorporated in this deed as if set out (with any necessary modifications) in this deed and shall apply in relation to the New Charged Assets as they apply to the Charged Assets
- 5 2 Clause 5 1 above does not apply to clauses 3 1 (Fixed security) and 3 2 (Floating security) of the Security Agreement and in the case of clause 1 (Definitions and interpretation) of the Security Agreement is subject to clause 1 of this deed
- 5.3 The New Charged Assets shall be deemed part of the Charged Assets for the purposes of the Security Agreement

#### 6 Section 2(1) Law of Property (Miscellaneous Provisions) Act 1989

The terms of the Finance Documents and of any side letters between any parties in relation to the Finance Documents are incorporated in this deed only to the extent required to ensure that any purported disposition of the New Property contained in this deed is a valid disposition in accordance with s 2(1) Law of Property (Miscellaneous Provisions) Act 1989

#### 7 Finance Document

For the purposes of the Facility Agreement the parties designate this deed as a Finance Document

### 8 Counterparts

This deed may be executed in counterparts, all of which when taken together shall be deemed to constitute one and the same instrument

#### 9 Governing law

This deed and any non-contractual obligations arising out of or in connection with it are governed by English law
