Notes to the Accounts

- 1. The New Harmony Press Ltd is a Company limited by Guarantee with Cooperative Articles of Association. There is therefore no share capital simply £16.00 of members guarantees
- 2. Creditors. There has been no opportunity to market the books and hence no additional author's royalties have accrued. The royalty figures are owed to the two founders of the Company/Co-operative who have waived payment until there are sufficient funds available without threatening the continuation of the organisation.
- 3. Current Liabilities. The members have and continue to provide labour and other material assistance without charges and fees as a result the Directors Loans figure has remained static for a number of previous accounting periods. By agreement there has been a reduction in the amount owing to directors (owed from the early days of the foundation of the Journal and NHP Ltd by the two founding directors/members Dr Peter Davis and Mr John Donaldson) in order to balance the books for the current financial period.
- 4. There was one edition of the *International Journal for Co-operative*Management Vol. 7.1. in 2014. Editorial and marketing work was provided by the New Harmony Press Directors, the design, printing, publication charges were met by the research account for the Saint Mary's University, who sponsored this issue. The journal's purpose remains the dissemination of academic research, including case studies of best practice, and the provision of a focal point for the development of a research and practitioner community concerned with co-operative management and organisational development.
- 5. The Company Secretary regrets to report there has been no opportunity to develop the Moodle platform further during this financial year owing to a lack of volunteer capacity.
- 6. Work is continuing on a voluntary basis to produce another issue (7.2) in August 2015. The Editor reports we have enough materials for this and a subsequent issue
