

We, the undersigned, being all the members of the Charity entitled to receive notice of and attend general meetings, hereby pass, pursuant to Article 14.8 of the Charity's Articles of Association, the following resolution as a Special Resolution:

'That the Charity's Articles of Association be amended as follows:

- 1. Article 5.2 of the Charity's Articles of Association be amended so that the words 'subject to any probationary period as set out in Article 5.11' be inserted so that the first sentence reads as follows:
  - "The Governors shall hold office for a term of four years, subject to any probationary period as set out in Article 5.11, and shall consist of....'
- 2. Article 5.7 of the Charity's Articles of Association be amended to delete 'or' at the end of Article 5.7(f), and insert it at the end of Article 5.7(g), and to include a new Article 5.7(h) which reads as follows:
  - 'reaches the end of his/ner probationary period without confirmation of continued appointment as set out in Article 5.11'.
- 3. A new Article 5.11 of the Charity's Articles of Association be inserted to read as follows:
  - of the probationary period, the Governor's term of office will automatically terminate unless his/her continued appointment for the remainder of the four year term has been confirmed in writing by the Chair of Governors. The probationary period will not apply to any subsequent re-appointment (including where the previous appointment was under Article 5.3) nor to the appointment of an



individual who has already served for 12 months as a co-opted Governor in accordance with Article 5.8.
