SPECIAL RESOLUTION

of



THE GODOLPHIN AND LATYMER SCHOOL FOUNDATION

(the 'Charity')

Passed on 1 December 2022

We, the undersigned, being all the members of the Charity entitled to receive notice of and attend general meetings, hereby pass, pursuant to Article 14.8 of the Charity's Articles of Association, the following resolution as a Special Resolution:

'That the Charity's Articles of Association be amended as follows:

- 1. Article 5.2(b) be amended to delete the following words:
 - "...,of whom not more than two may be appointed in accordance with Article 5.3 below";
- 2. Article 5.3 be removed in its entirety so that the following words are deleted:
 - "If the Governing Body see fit, not more than two of the Co-opted Governors may be Parent Governors appointed by the Governing Body to serve as such only whilst their child is a pupil at the school carried on or managed by the Charity. At the expiry of their term of office, they may be appointed under clause 5.2(b) and their term of office as a Parent Governor shall be ignored for the purposes of clause 5.5.";
- 3. Articles 5.4 to 5.10 be re-numbered as Articles 5.3 to 5.9, to reflect the removal of Article 5.3 as set out above, and all cross-references within the Articles of Association be updated accordingly;
- 4. Article 5.5(c) be removed in its entirety so that the following words are deleted:

 "A Parent Governor shall not be eligible for re-appointment as a Parent Governor.";
- 5. Article 5.11 be amended to delete the following words:"(including where the previous appointment was under Article 5.3)"; and



6. Article 19.2 be amended to delete the following words:

"'Parent Governor' means a Governor appointed in accordance with Article 5.2(c)".'
