SOLE MEMBER'S WRITTEN RESOLUTION

of

AQUILA POWER INVESTMENTS LIMITED (the *Company*)

BACKGROUND

The E ON UK group, of which the Company is a member, is undergoing a corporate restructuring (the *Restructuring*) to simplify its structure. As part of the Restructuring, it is proposed that the Company reduce its share capital in order to create distributable reserves. The Company requires distributable reserves in order to distribute certain assets, such distributions being integral to the Restructuring.

A solvency statement by the directors of the Company dated 26 November 2013 is enclosed with this document.

Pursuant to Chapter 2 of Part 13 of the Companies Act 2006 (the *Act*), the directors of the Company propose that the following written resolution be passed as a special resolution (the *Special Resolution*).

SPECIAL RESOLUTION

THAT, the Company be and is hereby authorised to reduce its issued ordinary share capital from £102,000,002 divided into 102,000,002 ordinary shares of £1 each to £2 divided into 2 ordinary shares of £1 each, in accordance with sections 641 to 644 (inclusive) of the Act, and that such reduction of capital be effected by cancelling 102,000,000 ordinary shares of £1 each in the issued share capital of the Company and that amount be credited to the Company's retained earnings reserve.

The undersigned, the sole shareholder of the Company entitled to vote on the above resolution on 26 November 2013 (the *Circulation Date*), hereby irrevocably agrees to the Special Resolution and confirms that it has received a copy of the directors' solvency statement at or before the time it received the copy of the Special Resolution as required by section 642(2) of the Act.
