# Progress in the Liquidations

## Asset realisations

Receipts and payments accounts are attached at Appendix C.

The only assets in the liquidations were intercompany balances or cash in hand as detailed on the receipts and payments accounts. These amounts have been distributed in specie to the Companies' respective members.

## HMRC

The Joint Liquidators have now received clearance for all of the Companies. It should be noted that numerous requests were made to HMRC for clearances which were delayed due to HMRC's backlog as a result of the COVID-19 pandemic.

A small refund was due to GGB Finance 4 Limited, and as it would have been uneconomic to open a liquidation bank account, we requested that this be paid to an appropriate AJG account.

## Creditors

There were no known creditors at the date of the liquidations. As previously reported, following our appointment we placed statutory advertisements in the London Gazette and Times newspaper inviting creditors to submit claims.

During the course of the liquidations, we were advised of a small claim against Honour Point Limited from British Telecommunications plc, and this has been settled by AJG.

## Return on capital

First and final distributions in specie were made to the Companies' respective members on 25 January 2024.

## Other matters

In addition to the above matters, we have dealt with all statutory matters required by legislation and administrative work incidental to our duties as Joint Liquidators.

## Joint Liquidators' remuneration

The Joint Liquidators' remuneration was approved on a time cost basis by the members.

Time costs to date of £87,123 have been incurred over 343 hours at an average rate of £254 per hour.

Since our previous progress report, time costs of £21,498 were incurred over 63 hours at an average rate of £343 per hour.

As previously reported, as the Companies have no cash assets, the costs of the liquidations, including expenses, have been met by AJG.

A detailed report of the time incurred and a narrative of the work done since our previous progress report is attached in Appendix D.

## Joint Liquidators' expenses

A breakdown of expenses incurred and paid during the liquidations is set out in Appendix E.

## Appendix B

### Members' rights

Within 21 days of receipt of the Proposed Final Account, members with at least 5% in value of the total voting rights of all members having the right to vote at general meetings of the Companies or any member with the permission of court, may request in writing that the Joint Liquidators provide further information about their remuneration or expenses which have been itemised in the Proposed Final Account.

Within 14 days of receipt of the request, the Joint Liquidators must provide all of the information asked for, unless they think that:

- the time or cost in preparing the information would be excessive, or
- disclosure of the information would be prejudicial to the conduct of the liquidations or might reasonably be expected to lead to violence against any person, or
- they are subject to confidentiality obligations in respect of the information.

The Joint Liquidators are also required to give reasons for not providing all of the requested information.

Members with at least 10% in value of the total voting rights of all members having the right to vote at general meetings of the Companies may, within eight weeks of receipt of the Proposed Final Account, make an application to court that the basis fixed for the Joint Liquidators' remuneration, the remuneration charged, or the expenses incurred by the Joint Liquidators, as set out in the Proposed Final Account, are excessive.

The Joint Liquidators may conclude that the affairs of the Companies are fully wound up before 5 April 2024 if every member confirms in writing to us that they do not intend to make any request for further information about remuneration or expenses or a court application.

When the affairs of the Companies are fully wound up the Joint Liquidators will make up the Final Account and deliver it to the members. When the Final Account is delivered to the Registrar of Companies the Joint Liquidators will be released under Section 171(6) of the Act.
