After our appointment, we wrote to HMRC to inform them of our appointment and to request details of any outstanding liabilities.

All matters have now been cleared and HMRC have confirmed their agreement to us closing the liquidation.

Distributions to shareholders:

At the time of our appointment, the issued share capital of the Company consisted of 1,000 Ordinary £1 shares.

On 29 December 2017 we made a distribution in specie of £1,061.19 (representing £1.06 per share) to the ordinary shareholders.

The distribution in specie consisted of an intergroup debtor balance totalling £1,016.19. The value attributed to the in specie distribution was based on the value at which the asset was held in the Company's books.

OUR FEES AND EXPENSES

Basis of remuneration:

At the time of our appointment, a resolution was passed for us to be paid by reference to the time properly given by us and our staff in dealing with the liquidation.

Funding of the liquidation:

Although fees have been paid to us on the basis specified above, our fees and expenses have not been paid out of the liquidation estate. Instead, Drax Corporate Limited has met our fees and expenses for the Company and 1 other connected company, Drax Ouse which was also placed into Members Voluntary Liquidation on 1 December 2017.

Remuneration charged:

Our fees for the period covering the formal liquidation to date are £11,833.

The above time costs for the liquidation period are calculated to 23 May 2018, being the latest practicable date. This represents 37 hours at an average hourly rate of £319.81.

£8,083 (excluding VAT and disbursements) has been invoiced for this case. It is our normal practice to obtain the prior approval of Drax Corporate Limited before fees are invoiced and final fees of £3,750 (excluding VAT and disbursements) have been agreed and invoiced.

Liquidators' expenses:

During the liquidation we have incurred expenses of £458.00 plus VAT. These costs, which will be or have been re-charged, consist of:
