The declaration of solvency, sworn by the directors prior to the commencement of the liquidation, showed an intercompany debt of £100 28 due from British Sky Broadcasting Limited ("BSkyB") The debt will be distributed by assignment to the sole shareholder of the Company, Teamtalk Media Group Limited (in members' voluntary liquidation)

The Company had no known creditors A notice to creditors to prove their claims in the liquidation was advertised in The London Gazette and The Times Newspaper on 5 July 2011 No creditors were forthcoming as a result of this advertisement

Searches of the Index Of Proprietors Names at HM Land Registry (in the Company's present and former names) proved negative

Tax

All pre liquidation corporation tax matters were handled by BSkyB Limited who prepared and submitted all outstanding returns to the date of the commencement of the liquidation to HM Revenue and Customs ("HMRC") The joint liquidators sought and received confirmation from HMRC that the Company had no outstanding corporation tax returns or liabilities, that it would not raise enquiries into any pre or post liquidation periods and that it had no objection to the liquidators calling a final meeting of members to conclude the liquidation

A similar assurance was sought and received from HMRC in respect of VAT

Clearance has been requested in respect of PAYE

Distributions

There were no distributions made to shareholders during the course of the year

Joint liquidators' remuneration and expenses

A written resolution was passed on 23 June 2011 that the remuneration of the joint liquidators be fixed at their normal charging rates according to the time properly spent by them and members of their staff in attending to matters arising in the winding up of the Company

In the event, the liquidators' remuneration will be paid by BSkyB and accordingly no detailed analysis is included in this report
