1. REPORTING ENTITY

These financial statements are prepared for CommodityClear Limited (the "Company"), which is dormant. The Company is a wholly owned subsidiary of LCH Limited and its ultimate parent company is London Stock Exchange Group plc.

The Company is a private limited company, incorporated in the United Kingdom and registered in England & Wales.

2. SHARE CAPITAL

Particulars of the Company's share capital are as follows:

The issued share capital of the Company is £1, (2016: £1), comprising 1 (2016: 1) ordinary share of £1 (2016: £1).

3. RELATED PARTY TRANSACTIONS

There have been no transactions with related parties requiring disclosure in either 2017 or 2016. The Company is dormant and all statutory fees are paid by the parent company.

4. ULTIMATE HOLDING COMPANY

London Stock Exchange Group plc is the Company's ultimate parent company and the largest company that prepares consolidated accounts. LCH Group Holdings Limited is the parent of the smallest group of companies that prepares consolidated accounts.
