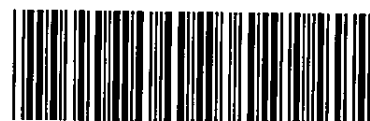



Formal Proposals - the Joint Administrators propose in respect of each company that they:

- a) they continue to realise assets in accordance with objective 3 of the statutory purpose of the Administration, and
- b) they exit the Administration by way of dissolving each company under paragraph 84 of Schedule B1 of the Insolvency Act 1986.
- c) creditors consider and if thought fit appoint a creditors' committee to assist the Joint Administrators (such committee must comprise of between 3 and 5 creditors)

In the absence of a creditors committee, that:

- d) the Joint Administrators' remuneration be approved on a time cost basis subject to the approval of the secured creditors (under Rule 2.106(5A) of the Insolvency Rules 1986)

A further resolution is put to the creditors:

- e) the Joint Administrators be discharged from liability under the Administration per Paragraph 98 of Schedule B1 of the Insolvency Act 1986, 28 days after the Joint Administrators' filing their final report to creditors
