# STRUCTURE, GOVERNANCE AND MANAGEMENT Governing document

The organisation is a charitable company limited by guarantee, incorporated on the 27th November 1998. The company was established under a memorandum which established the objects and powers of the company and is governed under its Articles of Association. The company became a charity pursuant to Special Resolutions passed at its Annual General Meeting held on the 27th June 2001 and written resolution dated 26th September 2001. Subsequent amendments widening the area of beneficiaries to include the electoral ward of Aberavon and thereby a name change were adopted dated 29th September 2004 and ratified with a written resolution on the 9th March 2005. In the event of the company being wound up the director trustees are required to contribute an amount not exceeding £10.

On the 3<sup>rd</sup> of September 2012 AGM, following a year of community consultation the charitable company amended its memorandum and articles of association to include the Constituency of Aberavon in its area of beneficiaries and changed its name. The Changes have been registered with the Charities Commission and Companies House during the financial year 2012/13

### Recruitment and appointment of new trustees

The directors of the company are also charity trustees for the purposes of charity law and under the company's Memorandum and Articles are known as director trustees and members of the Board Under the requirements of the Memorandum and Articles of Association the members of the Board are elected at the AGM. The Board has adopted bye-laws to allow free membership of the organisation and ensure that of the 18 permitted director trustees 9 will be residents in the constituency of Aberavon and shall comprise one from each electoral Ward, 3 shall be appointed from communities first/NSA Afan Stakeholder meetings and 3 shall be from business

A councillor from each of the 4 wards is nominated from the council itself and 3 people are appointed from businesses in the area. Any vacancy within the Board is advertised prior to the AGM and appropriate nominations invited from the membership of the organisation or by way of introduction in the case of business nominees.

The Board has appointed a paid Chief Executive Officer who shall direct all operations, business planning, business administration, human resource management, finance and marketing of the company's community regeneration mission

#### Induction and training of new trustees

All Trustees are familiar with the running of the organisation. They meet five times a year in scheduled Board meetings and set the budget for the year and decide on the strategic direction of the company for the ensuing year. New trustees are inducted into their role by the Chief Executive. They have adopted a business plan for the period 2010-2013. The plan has been produced in association with Dutton Jones Associates and sets out the organisation's goals for the next 3 years and seeks to achieve a sustainable future for the organisation.

Most trustees have participated in a "Charity Trustee Responsibilities" training event which we bought in from the local Council for Voluntary Services They also are involved in shadowing and mentoring as required

All trustees are invited to quarterly stakeholder days, where they contribute to a range of subjects including the setting of targets

Trustees are very familiar with the running of all aspects of the organisation by receiving the Chief Executive's report and the minutes of the Senior Management team on a monthly basis

Trustees conform with all aspects of charity law and a visit in 2006/07 by the Charities Commission review team helped strengthen the charity and the role of its trustees. This is reflected in the Memorandum and Articles of Association.

There are various leaflets directly presented to the Trustees explaining the work of the organisation "Who we are and What we do" and every issue of the community regeneration magazine called "Making Waves" in addition the minutes of the Senior Management team's monthly meetings are sent to the trustees for information on work in progress

#### Organisational structure

NSA Afan has a board of director trustees which meets 5 times a year and are responsible for the strategic direction and policy of the charity. At the year end the Board has 18 director trustees and there is therefore one vacancy. The trustees represent a number of residents and community interests as well as three councillors and those with business and professional backgrounds. The company secretary also sits on the Board but has no voting rights.

As referred to above a scheme of delegation within a management structure is in place and the 'day to day' responsibility for the management and delivery of all programmes, projects and services rests with the Chief Executive Officer who also manages all development, operations, business planning, business administration, human resource management, finance and marketing of the company's community regeneration mission. This is accomplished via a management structure via a senior management team and various finance, funding, development and operations management teams reporting their work vertically as well as horizontally

#### Management structure

A management structure is in place and is referred to as an organisation chart attached to the business plan

The management structure that is in place is to implement the neighbourhood plan and the NSA business plan objectives for 2010-2013. In view of the development status of most operations the company has reverted to a 2 directorate structure whereby the Chief Executive officer has day to day responsibility for business management and operations with the development directorate being placed strategically in existing operations to enable sustainability and continuation of key projects.

### Related parties

In so far as it is complementary to the charity's aims, the charity is guided by the Welsh Governments Communities First programme, its policies on social enterprise, social inclusion and regeneration, life long learning and skills and innovation, enterprise and networking. In addition the NPTCBC Community plan and related community strategies that may from time to time complement the charity's objects.

We work in partnership with a number of organisations who have interest in or a base in Sandfields, Aberavon and the wider Neath Port Talbot and Swansea Bay area and who support residents in all aspects of the quality of their lives

### The activities of community regeneration within NSA

#### A NEW COMMUNITY REGENERATION ORGANISATION

In September 2012 NSA Afan was legally constituted by the coming together of two organisations. NSA and The Upper Afan Forum. A working party of members of both Boards of Director/Trustees had been working on the new combine structure of the organisation for over a year. It was recognised that we had more in common than we realised. We now cover the electoral constituency of Aberavon. From the Upper Afan in the North to the Sandfields and Aberavon in the South the new community Regeneration. Company is committed to long term sustainable community regeneration.

The new Board comprises residents with community, social, political and business interests from the villages of Gwynfi, Glyncorrwg, Croeserw, Cymmer and Duffryn as well as the community of Sandfields and Aberavon It has registered a new name for its main charitable operations "New Sandfields Aberafan and Afan – Community Regeneration" Its working Title is "NSA Afan" It also has a Trading Arm "New Sandfields Aberafan and Afan (Community Trading) Ltd " All changes have been registered with the Charities Commission and Companies house

The work of the new organisation is to continue its Community Regeneration strategy through its Lead Delivery Body work delivering the programme of the Communities First Cluster for Sandfields and Aberavon. At the same time the new organisation will deliver a community asset development strategy for the Upper Afan that will lay the basis for providing community regeneration opportunities and facilities that will enable engagement with the community based on their expressed and perceived needs

### BUSINESS AS USUAL FOR THE MAIN PROJECTS AND PROGRAMMES

#### Our projects and services.

### **Communities First**

2012/13 resulted in the conclusion of the previous Welsh Government's Communities first funding programme that had been in place since 2001. This included its obligations towards the "Outcomes Fund" provided by Communities first in respect of its community engagement activities in the Bevin Avenue Development Centre.

### Towards a new Communities first programme 2013-2015.

NSA, as it was then, submitted its application to be the Lead Delivery Body for the top 10% most disadvantaged Lower Super Output Areas (LSOAs) in the new Communities First Futures programme in the Spring of 2012 NSA had delivered the Communities First programme in Sandfields Aberavon since 2002 as the Grant Recipient Body. In 2011, it was announced by Carl Sargeant AM, that Communities First would become more accountable by introducing Results Based Accountability (RBA). This new programme funding would be called, 'Communities First Futures.' This status, indicates the high levels of social disadvantage and deprivation that our community experiences. Three Wards have been divided into twelve Lower Super Output Areas (LSOA's) in the Welsh Index of Multiple Deprivation (WIMD) 2011. Eleven of the twelve have Communities First status. Seven of the twelve are in the top 10% most deprived LSOA's in Wales. The area of benefit has a total population of almost 24,000, which encompasses 7,982 households. 24.8% of the population is over sixty years of age. 32.8% have a life-limiting long term illness. 49.65% have no qualifications. 35.8% are claiming some kind of income related benefit. These are NSA's baseline statistics for the next phase of programme funding.

With this is mind NSA Afan participated in consultation process to help determine the areas of cluster operation. We bid to become the Lead Delivery Body (LDB) for the Upper Afan Valley. The process was concluded when the existing CF Partnerships voted by a very narrow margin to continue with the Local Authority as the LDB.

The new results based scheme aims bring together all stakeholders in communities to ensure that Communities First targets are met, by means of programme bending NSA's existing projects will be incorporated into the delivery plan and all stakeholders will be responsible for meeting those objectives via a Community Involvement Plan which is part of the criteria for the new funding applications. In January 2013 NSA were informed that had been awarded the LDB status for Sandfields and Aberavon.

We will also offer to become the delivery partner in certain project activity areas for the other clusters in NPT We consulted with all our stakeholders and gathered evidence and support for our full application which was submitted in January 2011. A Development period commenced and full operations began in January 2013 to March 2013.

### NSA Afan's Communities First activities 1<sup>st</sup> April 2012 – 31<sup>st</sup> March 2013:

#### Ten years of outcomes:

Communities First is a Welsh Government programme, tackling the most deprived Communities in Wales NSA Afan is the Grant Recipient Body and manages the programme in Sandfields East, West and Aberavon The team has been working in the community since 2001 and has had a great number of successes. By working in an integrated way with NSA Afan, our shared outcomes have enabled true community regeneration activities in the area. Below is a summary of our outcomes 2012-13.

NSA Afan's DWP Flexible Support Fund – 33 jobs, 4 volunteers/work experience with NSA Afan, 23 progressed into further learning and 162 other positive outcomes

NSA Afan's Engagement Gateway – 15 jobs, 6 volunteer placements, 55 positive outcomes and 7 people progressed into further learning

NSA Afan's Jobs Growth Wales Placements – 7 young people have gained valuable skills within NSA Afan

#### **Employment Support Centre**

NSA Afan has an outreach facility to deliver employment support activities in Windsor Road, Neath town centre. The employment team uses the centre to provide a point of engagement to deliver several contracts for DWP and WCVA's (engagement gateway) programme. The centre has facilities to offer a range of activities that includes job search, CV's, work experience and qualifications to help people who are unemployed or economically inactive. There has been over 224 participants engage with the facility and have successfully gained 133 outcomes to help them progress towards the labour market.

In June 2012 we successfully completed stage one of the Engagement Gateway programme that included project for the over 50's, a female only DIY and hair and beauty course, as well as other employment support activities. Over 500 people signed up to take advantage of the free support on offer and over 500 jobs, volunteering, further learning, qualifications and other positive outcomes were—achieved by the participants. The total value of all the contracts was £250,000. Due to its success we have been awarded another four contracts to provide employment and learning support, which includes a project to help people budget and help understanding their utility bills. The total value of all the contracts are £150,000.

#### NSA staff giving back to the community.

The NSA payroll giving Small Grants Scheme, run voluntarily by staff, again proved popular with small community Groups NSA Staff give up a few pounds a month with tax relief to help the community in their own way for which they are to be congratulated. Over £2,000 again was given as direct grants to community organisations. A further source of funding by the Communities First Trust fund also proved successful with the CF team securing a £55,000 allocation for local groups and projects which has been full subscribed.

NSA Afan PCCARE project is Social Enterprise of NSA Afan, offering IT Support and Solutions to community members, groups and local businesses within the Swansea Bay Area. In particular, we offer a "one stop shop" for the Asset Management of Redundant ICT Equipment.

NSA Afan PCCARE currently work with Seren, Careers Wales, Swansea CVS, NPT CVS, Groundworks, Swansea University, Dawn Group, various Schools and many more in managing their Asset Transfer of Redundant ICT Equipment which is refurbished when possible and re-distributed back into the Community



### **Lifelong Learning Courses**

The NSA Afan Community Development Centre facilitates a range of Adult Learning Courses in the heart of the community in partnership with a range of training providers. Courses are delivered daily Monday to Friday from 9am to 8 30pm (Monday to Thursday) and 9am to 5pm on Fridays. Courses range from Floritry Techniques and guitars to the Foundation Certificate in Humanities and the part time degree programme providing something for everyone.

### Supporting Youth in Aberavon.

This year NSA Afan secured funding from the Home Office and NPT Renewal Area to deliver 2 youth clubs, one in the Development Centre, Bevin Avenue, Sandfields, (Igloo Youth Club) and the other in St Mary's Church Hall, Aberavon, (SA12 Youth Club) Both clubs are open to young people aged between 11 and 25 Each session sees over 20 young people attending each club. The clubs encourages positive engagement in activities and discourages anti-social behaviour from young people.

We continue to deliver sports sessions for the Hopkin Street Multi-Use Games area once a week, where we engage with at least 15 young people per session. At the sessions the young people play different sports with the aim of getting more young people physically active

We also continue to offer activities in Aberavon during school holiday periods, to engage with young people and discourage them taking part in anti-social behaviour. This year we have held sessions at St Marys Church Hall during the Easter, summer and October half terms. Each session we arrange different activities, all free, such as arts and crafts, healthy food making, sports, games and much more. These events are very popular and we have over 60 young people attending session.

NSA Afan also secured funding to employ a link officer in Sandfields Comprehensive School His role is to work with young people that are beginning to disengage from school, have high absence rates and that have behavioural problems. The link officer works both one to one and on an individual basis with the young people in the school and look at reasons why they are starting to disengaged from school and what they can do to help improve the young person's behaviours and attitude.

### Planning ahead

We recognise that Community Development and Regeneration takes time and there are no short cuts to achieving quality applications for funds and quality schemes addressing people's needs. We recognise that we are involved in a marathon and not a sprint towards overnight successes that seem to appear from no-where. We base ourselves in the heart of the community and make our facilities accessible to all

NSA using its Business plan 2010 – 2013 as a guide to action and community development has set about implementing its Community Asset Development programme

- Work commenced on a £500,000 renovation to convert the Dalton Road Community Centre into an Employment Academy that will work alongside existing community groups using the centre
- We continue to seek to convert the former changing rooms facility at Rhodes Avenue into a Youth and Communities first facility with plans for a community Garden in that part of Aberavon
- One of our goals was to promote and sponsor the replacement of the LIDO with a new combined Leisure and Community Enterprise centre. We recognise that it will not now be possible to deliver community regeneration facilities and engagements from the new building of the Aberavon Leisure centre. A combination of budget/resource constraints and political priorities was decided by the Council's task and finish scrutiny committee in favour of a replacement of the former LIDO as an exclusive Leisure facility. Nevertheless NSA Afan looks forward to the creation of the new Leisure centre and supports its establishment and we wish it every success in providing services to the community and leisure users.

#### **ACHIEVEMENT AND PERFORMANCE**

### PV4Free. -

The Solar panel arrays approached their first anniversary and proved a big success in both reducing carbon generation, saving on day time electricity consumption and generating a positive return to NSA Afan's community regeneration work

NSA ExTRA – Throughout the year we enabled the transfer of the work with former Military personnel in support of their employability needs to "Healing the Wounds" a charity dedicated to meeting their needs. A former NSA Afan senior manager has taken up a management post with the Charity and the work was transferred and is supported in his new portfolio.

**Making Waves** – Established in 1999 and now in its 39<sup>th</sup> edition, Making Waves describes the work of NSA A community magazine created and published by NSA which is distributed to 9,000 households within Sandfields and Aberavon. Two issues were distributed throughout the year explaining the work of NSA with Communities First, especially the work of the NSA SAVE Committee of committed volunteers who organise the NSA Beach festival and community based Christmas festivals.

The NSA Communities First Partnership. - The Communities first Partnership was disbanded to be replaced by stakeholder groups feeding into the new delivery programme of projects and activities around the 3 themes of \*prosperity, \*Learning and \*Health This will be the last year that Communities first is allocated funds for capacity building and community development work. It will in the future be results and outcomes based with an expectation of drawing more funds into community projects that meet the needs of people in the area.

The communities first funded programme in Sandfields Aberavon still aims to

- involve local people in improving their areas and their own prospects,
- bring in funding and support from a range of sources to make things happen,
- make sure improvements last,
- encourage flexibility, risk-taking and new ways of dealing with problems, involve everyone working together to identify and do something about their community's needs

The aims and objectives of NSA are, in all aspects, comparable with the objectives of Communities First. Each Communities First area is required to produce a Cluster delivery plan and a community involvement plan that sets out what their community wants and how that will be achieved. Every plan should cover themes identified by both the Welsh Government and the community. The main themes are now Prosperity, Education and Health.

### Partnership working

The main areas of charitable activity for NSA Afan are community events, the provision of employment training, post 16 community education courses, advice, information and support. Asset development also takes place to provide facilities for projects that tackle the needs identified in the NSA Business Plan 2010-2013. Partnership working is an important area of our work with youth providers, NPT Adult Community Learning, Sandfields Comprehensive School and many other agencies who are voluntary or statutory agencies who are working in the community. We are a member of the Development Trust Association Wales and work with organisations with similar aims and objectives through Wales.

### Investors in people

The organisation was making progress through the Investors in People assessment and review process and an award was made in 2008. In 2011 the Award was reassessed and reissued, the IIP Assessor reported that, "people love working here — they are proud of both their individual achievements and NSA Afan as a whole. They fully appreciate the impact they are having on the community and they are dedicated to working in such a socially responsible way." The standard was maintained and exceed six other indicators.

### FINANCIAL REVIEW

### Reserves policy

It is the policy of the organisation to maintain unrestricted and designated funds to ensure sufficient reserves to meet six months of future running costs. At this level the Board are confident that they would be able to continue with the current activities in the event of a significant drop in funding

To date a sum of £19,389 is held in general reserves, a sum of £340,920 is held in designated reserves to cover future running costs, a sum of £30,000 set aside for employer pension provisions for obligations to occupational pensions for staff and those who wish to join the Pensions Trust Defined Benefit scheme, and £347,344 represents the amounts spent on fixed assets

The company has adopted a death in service scheme as part of its pensions obligations to staff and during 2009/10 the company converted to a modified pension scheme via a money purchase scheme called Series 4 within the Pensions Trust on 1st October 2009

The present level of reserves falls significantly short of the target. Although the strategy is to continue to build reserves through unrestricted income generation. The Board is well aware that it is likely to take at least another 4/5 years before we reach the target for reserves.

In the meantime the Board has a strategy to manage both restricted and unrestricted income with prudence and controls are in place to keep expenditure to a minimum and to agreed levels only. A policy is in place for financial regulations and for levels of authority to spend within the two Directorates.

#### 1. ACCOUNTING POLICIES

### **Accounting convention**

The financial statements have been prepared under the historical cost convention, and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008), the Companies Act 2006 and the requirements of the Statement of Recommended Practice, Accounting and Reporting by Charities

#### Basis of consolidation

The consolidated financial statements deal with the state of affairs and income and expenditure of the charitable company and its subsidiary undertaking, all of which were prepared to 31 March 2013. The results of the subsidiary are consolidated on a line by line basis within the consolidated Statement of Financial Activities (SOFA).

#### Incoming resources

All incoming resources are included in the statement of financial activities when the charity is entitled to the income and the amount can be qualified with reasonable accuracy. The following specific policies are applied to particular categories of income

- Voluntary income is received by way of grants and subscriptions and is included in full in the Statement of Financial Activities when receivable. Grants, where entitlement is not conditional on the delivery of a specific performance by the charity, are recognised when the charity becomes unconditionally entitled to the grant.
- Investment income is included when receivable
- Incoming resources from charitable activities are accounted for when earned
- Incoming resources from grants, where related to performance and specific deliverables, are accounted for as the charity earns the right to consideration by its performance

#### Resources expended

Expenditure is recognised on an accruals basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is reported as part of the expenditure to which it relates.

- Cost of generating funds comprise the cost associated with attracting voluntary income
- Charitable expenditure comprises those costs incurred by the charity in the deliverance of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.
- Governance costs included those costs associated with meeting the constitutional and statutory requirements of the charity and include the audit fees and costs linked to the strategic management of the charity

#### **Taxation**

The charity is exempt from corporation tax on its charitable activities

#### Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees

### 1. ACCOUNTING POLICIES - continued

Restricted funds can only be used for particular restricted purposes within the objects of the charity Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements

### Hire purchase and leasing commitments

Rentals paid under operating leases are charged to the Statement of Financial Activities on a straight line basis over the period of the lease

Assets obtained under finance leases are capitalised in the balance sheet and depreciated over their estimated useful lives, or where relevant, the lease term, whichever is shorter

Rentals paid under operating leases are charged to the income and expenditure account as incurred

#### **Pensions**

The charitable company operates a defined contribution pension scheme Contributions payable to the charitable company's pension scheme are charged to the Statement of Financial Activities in the period to which they relate

The company operates a money purchase scheme with a defined pension scheme called 'Pensions Trust'

The organisation operates a pensions accrual policy whereby 8% of all staff salary irrespective of funded or unfunded posts are deducted and transferred to an Employer's designated fund to meet any future obligations and to ensure Staff have the right to apply to john the scheme and have their contributions and that of the employer back dated to commencement of employment

#### Fixed assets

Fixed assets are stated at cost less accumulated depreciation. The cost of minor additions or those below £1,000 are not capitalised. Depreciation is provided at rates calculated to write off the cost of each asset over its expected useful life, as follows.

NSA Afan STRIDES Alliance is co-funded by NSA Afan and the Welsh European Funding Office NSA Afan STRIDES Alliance is an Agored Cymru and City and Guilds registered centre offering units and qualifications up to level 2. The project engages with the unemployed and economically inactive throughout Neath and Port Talbot to develop employability skills and motivation with a view to assisting them into employment or further learning. This is achieved through simulating working environments in Business Administration, ICT and Hair & Beauty, as well as offering accredited workshops in Literacy and/or Numeracy, Confidence Building, Financial Awareness, CV writing and applying for employment vacancies.

Communities First – Is funded by Welsh Government and it's main aims are to achieve to help alleviate poverty in Sandfields East, West & Aberavon Its activities are based around the theme of prosperous communities, learning communities & healthier communities

Contracts - NSA Afan work with the government to deliver employment & training outcomes for unemployed & economically inactive people Contracts are paid based on outcomes achieved

Crime & innovation – Appoint a schools link officer & 4 youth workers to develop an innovative project to A, Support young people who are at risk of being disengaged B, To re-open an un-used youth club

Big Lottery – Awarded funds for capital & revenue to renovate Dalton Road community Centre & to provide employment related activities for un-employed & economically inactive people

Jobs Growth Wales - The programme caters for young people that are job ready but have had difficulty securing employment. The Jobs Growth Wales programme provides unemployed young people aged 16-24, with a job opportunity for a six month period paid at national minimum wage. Participants will be paid at or above the national minimum wage for a minimum of 25 hours per week.

Young people will be employed for the duration of the programme and the jobs created must be additional to, and not replace, positions that would otherwise be filled

There are three designated funds in place

- to cover future running costs should funding stop.
- the cost of pension payable should the charity cease
- the reflect the amount of funds held as fixed assets

#### Transfers

There have been two material transfers between funds during 2013

A transfer of £269,344 into designated – capital expenditure from the general fund, this relates to the allocation of general reserves that are held as fixed assets

A transfer of £230,438 into WEFO/Convergence – STRIDES Alliance from the general fund, this relates to the match funding agreement that was entered into whereby the charity would cover any costs not met by the grant received
