

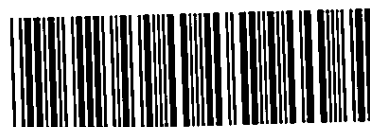

AMENDED ORDER

UPON THE PETITION of Affinity Internet Holdings Plc ("**the Company**") presented to the Court on 24th September 2007 by its Vivian Bairstow and Nicholas Hood ("**the Joint Administrators**")

UPON HEARING COUNSEL for the Joint Administrators

AND UPON READING the documents recorded in the Court file as having been read

AND the Court being satisfied on the evidence before it that the EC Regulation on Insolvency Proceedings (Council Regulation (EC) No 1346/2000) ("**EC Regulation**") does apply and that these proceedings are main proceedings as defined in Article 3 of the EC Regulation

IT IS ORDERED THAT:

- 1 The administration order made in respect of the Company on ~~7th July 2003~~ 7th April 2003 be discharged.
- 2 The Company be wound up by the court under the provisions of the Insolvency Act 1986

- 3 Vivian Bairstow and Nicholas Hood be appointed as joint liquidators of the Company pursuant to section 140 of the said Act
- 4 The Joint Administrators be released from all liability pursuant to section 20 of the said Act, such release to take effect 28 days after they have filed their final abstract of receipts and payments pursuant to Rule 2 52(1)(b) of the Insolvency Rules 1986, save in respect of any claim notified prior to that date
- 5 The costs of and incidental to the Petition be paid as an expense of the administration
