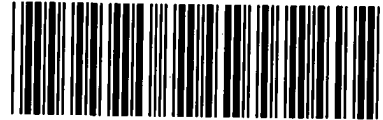

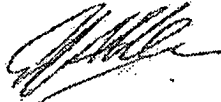

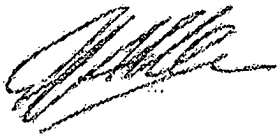
**Option Deed (Water Supply) dated 30 May 2000 made between Baglan Generating Limited and BP Chemicals Limited (the "Contract").**
