- 3. The objects for which the company is established are to secure high standards of excellence and quality for the inspection of Equipment to include Pressure Vessels, Cranes, & Lifting Equipment and the Audit and Accreditation of Quality Control Systems. For the said purposes the Company may:-
- a) establish procedures relating to the inspection of equipment only within its accredited scope. And shall not be the designer, manufacturer, supplier, installer, purchaser, owner, user or maintainer of the equipment.
- b) carry out inspections and report on the findings of but not limited to; policyling the quality of materials, components, apparatus, equipment, production, service methods and processes of all kinds for the purpose of testing their competence to ensure compliance with plans, specifications, legal requirements, rules, codes of practice, established standards or fitness for particular requirements;
- c) act on behalf of or as authorised by any government or other authority in such capacity and to such extent as may be agreed in respect of statutory requirements;
- d) make appointments of suitably qualified persons who shall monitor and fulfil the foregoing objects subject to (where requisite) the approval of, or any directions or regulations issued from time to time by or on behalf of, the Secretary of State for Trade and Industry and also in accordance with the requirements of EN45004 & EN45012, and any subsequent amendments thereto, which shall in their turn have such powers and responsibilities as may be laid down by the Articles of Association of the Company from time to time;
- e) achieve Accreditation to the requirements of EN45004 & EN45012 at its most recent issue status and thereafter to maintain registration as a Notified Body;
- act as agents or brokers or trustees for any person, firm, company, society or other organisation and undertake and perform subcontracts and also act in respect of any of the activities of the Company through or by means of agents subcontractors or others;
- g) acquire and undertake the whole or any part of the business goodwill and assets of any person, firm or body corporate carrying on or proposing to carry on any of the businesses which the Company is authorised to carry on or which can be carried on in conjunction therewith or which are capable of being conducted to the benefit of the Company;
- h) enter into any arrangement with any government or authority (supreme, municipal, local or otherwise) or any corporation, company or person that may seem conducive to the Company's objects or any of them and to obtain therefrom and to carry out, exercise and comply with any charters privileges and concessions which the Company may think desirable;
- institute and carry on or defend legal proceedings relating to matters affecting the interest of the Company and to assist
 other persons and bodies engaged in legal proceedings relating to any matter which may affect, directly or indirectly the
 Company's work and objects;
