DIRECTORS' REPORT

The directors present their annual report and the audited Financial Statements of TMC Tattenham No 2 PLC ('the Company'), registration no 3701693, for the year ended 30 September 2009

BUSINESS REVIEW AND PRINCIPAL ACTIVITIES

The Company is a wholly owned subsidiary of Mortgage Trust Services PLC The Company's ultimate parent company and ultimate controlling party is The Paragon Group of Companies PLC ('the Group') The Company was established for the sole purpose of issuing floating rate notes secured by pools of residential mortgages

On 7 April 2006 the Company was acquired by Mortgage Trust Services PLC from The Mortgage Corporation A consideration of £1,392,000 was paid

The principal activity of the Company was the ownership of pools of residential mortgages. The majority of loans were sold to another group company. The Company retained the remaining loans and will continue to actively collect on these loans.

The Company's profit and loss account is shown on page 5. The result after tax has improved from a retained loss of £6,000 to a retained profit of £1,000.

The balance sheet on page 6 of the financial statements shows that the Company's financial position at the year end Net assets have increased due to the retained profit for the year Details of amounts owed to other group companies are shown in note 11

The directors recommend no final dividend (2008 £nil) which, given the interim dividend of £nil per share (2008 £3 00 per ordinary share), means a total dividend for the year of £nil per share (2008 £3 00 per ordinary share)

The Group manages its operations on a centralised basis. For this reason, the Company's directors believe that further key performance indicators for the Company are not necessary or appropriate for an understanding of the development, performance or position of the business. The performance of the Group's mortgage lending operation, which includes the Company, is discussed in the Group's Annual Report, which does not form part of this Report.

PRINCIPAL RISKS AND UNCERTAINTIES

The Company's primary financial assets and liabilities are with other group companies, therefore the directors do not consider that the Company is exposed to any significant cash flow, credit or liquidity risks

After considering the above, the directors have a reasonable expectation that the Company will have adequate resources to continue in operational existence for the foreseeable future. For this reason, they continue to adopt the going concern basis in preparing the annual accounts

The Group recognises the importance of its environmental responsibilities, monitors its impact on the environment, and designs and implements policies to reduce any damage that might be caused by the Group's activities. The Company operates in accordance with Group policies, which are described in the Group's Annual Report, which does not form part of this Report.
