#### **Progress Report:**

- You will recall that I, Kikis Kallis, was appointed Administrator in this matter on 16<sup>th</sup> December 2003. My proposals were approved by creditors at a meeting held on 30<sup>th</sup> March 2004 and my revised proposals approved at a meeting held on 19<sup>th</sup> November 2004, for the purose of extending the period of the Administration for a further six months.
- In accordance with my revised proposals I write to provide you with my final progress report on the conclusion of the administration and the company moving into creditors voluntary liquidation.
- Attached is an abstract of my receipts and payments account for the tenure of my appointment as administrator which is self-explanatory.
- My original proposals envisaged that
  - the administration would deal with the efficient managing and realisation of the company's assets.
  - that on conclusion of the above matter the administrator, if he thinks fit, place the company into creditors voluntary winding up.

- My revised proposals stated that
  - the period of the Administration be extended for six months to 15<sup>th</sup> June 2005.
- I would advise that the Administration has progressed as anticipated, and an agreed contract for the sale of the business and its intellectual property has now been formally agreed and completion thereof has taken place. The consideration for this sale is £30,000 on completion of the agreement, and this has been received, along with a sum in pounds sterling the equal to 2% of the Local Advertising Turnover due in Year 1. This is subject to a maximum aggregate payment of £50,000 payable quarterly in arrears. Due to the delays with the realisation of the company's assets and the ongoing protracted negotiations this has resulted in higher costs than originally anticipated. This coupled with lower realisations than expected has substantially reduced the availability of funds for the payment of a dividend to any class of creditor.
- The liquidator will receive the balance of funds due in respect of the sale of the business. There are no other assets to realise.
- Finally, since last reporting to you I would advise that for the period since my appointment on 16<sup>th</sup> December 2003 to 11<sup>th</sup> February 2005 the time spent by my staff and I on this matter totals 237.13 hours amounting to a cost of £43,447.25 at an average rate of £183.22 per hour.

In accordance with the approved and revised proposals I have received sanction to discharge my work in progress in full. I would advise however that this has been restricted to £23,467.45. My disbursements remain unpaid. A breakdown of this time is provided below:-
