The company is exempt under Section 228 of the Companies Act 1985 from the requirement to prepare consolidated financial statements as it and its associated undertaking are included by full consolidation in the consolidated financial statements of its ultimate parent Carlsberg A/S, a company registered in the EU

E Taxation
