OPINION

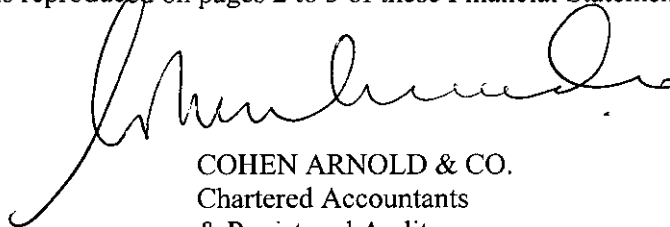

DEPARTURE FROM ACCOUNTING STANDARDS

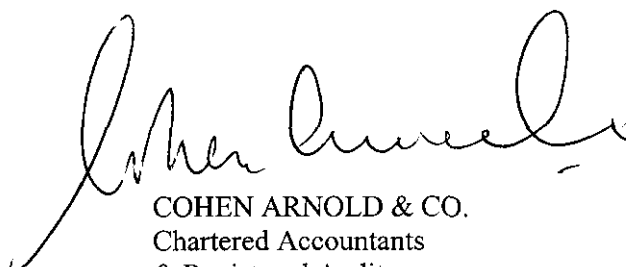
