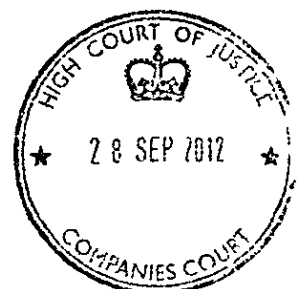
And upon hearing Counsel for the Administrators


