

JOINT LIQUIDATORS' ACTIONS SINCE APPOINTMENT

Since our appointment as Liquidators, we have completed our statutory notifications and brought the Company's tax affairs up to date with the assistance of the Company's accountant. A claim was received from HM Revenue & Customs for PAYE arrears relating to CCP costs for periods between 2011 and 2014. All payments had been made by the Company and tax clearance was sought and has now been received from HM Revenue & Customs therefore the liquidation can now be moved to closure.

There is certain work that we are required by the insolvency legislation to undertake in connection with the liquidation that provides no financial benefit for the members. A description of the routine work undertaken since our appointment as Liquidators is contained in Appendix 2.

Joint Liquidators' expenses

A Description of Routine Work Undertaken

1. Administration and Planning
