## REVIEW OF THE BUSINESS

During the year there have been two appointments to the Board and two departures. BNY Corporate Directors Limited and BNY Directorate Services Limited were each appointed as an additional Director on 16th November 2005. Shelfco Holdings Ltd. and Shelfco Ltd. each resigned as a Director per their letters of resignation each dated 18th November 2005.

There are no directors' interests requiring disclosure under the Companies Act 1985.


