## Administrator's Final Progress Report to Members and Creditors pursuant to Rule 2.117 of the Insolvency (Amendment) Rules 2003

The Administrator of the Company makes the following report further to his appointment on 22<sup>nd</sup> July 2005.

#### 1. Receipts and Payments

A summary of my receipts and payments account is attached hereto which I trust you will find self-explanatory.

A more detailed report was provided in my 6-month report which was already provided. However, further progression has been made with the following matters:-

### 2. Film Rights

I can confirm that there are discussions with interested parties in relation to the film rights in the films 'Good Omens' and 'Strange Beds'. These discussions are ongoing and will be continued by the duly appointed Liquidator.

#### 3. Administrator's Remuneration

Administrator's Remuneration has been drawn on a time costs basis, as previously agreed by creditors.

I can confirm that, to date, a total of 134 hours has been spent by myself and my staff in dealing with this matter, incurring a total of £20,938.75 in time costs which equates to an average hourly rate of £156.26. A breakdown of these costs will follow shortly.

#### 4. Administrator's Expenses

Expenses have also been drawn in accordance with the guidelines set out in the creditors guide to fees which was previously sent to creditors with the original Proposal.

#### 5. Creditors' Claims

Creditor's claims shown in the Statement of Affairs totalled £385,794.03 and formal claims that have been received have amounted £493,131.61. The substantial increase of claims is mainly as a result of those submitted by Crown Departments, totalling £194,915.67.

#### 6. Dividend

The Administrator is still confident that he may be able to recover sufficient funds with which to make a distribution to creditors once all claims have been received and agreed.

#### 7. Other Matters

As this administration is now 12 months old I am required to either make a Court application to extend the term of the administration or to put the company into liquidation. After considering the matter in detail, I am of the opinion that there is no benefit to continuing with the administration and that the conduct of the case can continue through liquidation by the duly appointed Liquidator. It is also the case that it would be more advantageous for the Company to move to Creditors Voluntary Liquidation, in accordance with paragraph 83, as, by placing the Company into liquidation, the Liquidator would have wider powers to realise assets and pursue, if necessary, offences which may have been committed by the Director.

I can confirm that there will be a balance of £2,758.88 held on the Administration Account which will be transferred to the liquidation.
