

 - (iv) That where no Liquidation or Creditors' committees have been appointed it is open to any creditor to apply to court for an order that the Respondent do provide such information as might otherwise be required by Rule 4 108(3) or Rule 6 126(2) (as the case may be), provided such an application is made within 28 days of this Order
 - (v) That if the Respondent is required to provide the information referred to in paragraphs 5(iii) or 5(iv) above the costs of doing so will, unless there are good reasons to the contrary, be paid as an expense of the bankruptcy or winding up as the case may be
 - (vi) That each creditor and member (as the case may be) in respect of each of the Proceedings has a right under Regulation 11(1) of the Insolvency Regulations 1994 (compulsory winding up), Regulation 11(2) (voluntary winding up), or Regulation 25 (bankruptcy) (as the case may be) to require the supply of a statement of receipts and payments free of charge



- (c) Any costs and expenses incurred by the Applicant and/or the Respondent in connection with this Application which are not recoverable in accordance with paragraphs 7(a) & 7(b) above, be paid by the Respondent

PROVIDED THAT in no case shall the total of such remuneration, costs and expenses (including VAT) payable under 7(a) and 7(b) above exceed 10% of the value of the realised assets in that particular matter
