Statutory information

I, Malcolm Cohen, of BDO LLP, 55 Baker Street, London, W1U 7EU was appointed as liquidator of the Companies on 7 May 2014. Their respective company numbers and former company names are detailed in the attached schedule.

Liquidator's Remuneration

My remuneration was approved on a time cost basis on the date of my appointment. As the Companies have no cash assets, the liquidation costs will be paid by a group company.

To 11 July 2014, time costs were incurred by the liquidator and his staff totalling £9,358.25 for all three Companies. This relates to 33.8 hours of work at an average rate of £277 per hour. Please note further time costs have been incurred in the period to closure.
